Minister announces work is to commence on development of Social Inclusion Strategies

Communities Minister Carál Ní Chuilín has announced work is to commence on the development of the suite of Social Inclusion Strategies.

Anti-Poverty, Disability, Gender Equality and Sexual Orientation Strategies will aim to address barriers and inequalities in society and to fulfil the commitments in New Decade, New Approach and the Executive's Programme for Government.

It is anticipated that all of the Strategies listed above will be published by the end of 2021, subject to Executive agreement.

The term of the last Child Poverty Strategy expired in March 2019. Due to the absence of the devolved institutions, it was not possible to produce a new Strategy at that time. Departments however, continued to report annually on their respective actions contained in the Child Poverty Strategy Action Plan. The Minister will work with the Executive and key stakeholders to decide the best way forward in relation to dealing with Child Poverty.

The current Active Ageing Strategy 2016-2021 is due to conclude in January 2021.

The Minister will shortly be engaging with Executive colleagues in relation to the options for the treatment of this Strategy post 2021.

Announcing details of the timetable, Minister Ní Chuilín said, "I am delighted that work is to

commence on these new Social Inclusion Strategies, which aim to tackle the inequalities and obstacles that directly affect the everyday lives of many people in our community."

"Community engagement will be a key factor in their development and I am keen to ensure that the people most affected have the opportunity to make a meaningful contribution to their development and delivery."

The Minister continued, "Whilst my Department is in the lead on the development of these Strategies, it is important to note the issues to be addressed cut across all Executive Departments. I will work closely with Executive colleagues and other Departments to ensure that each Strategy is underpinned by an action plan containing targeted, measurable and resourced actions focused on the areas of greatest need identified by our stakeholders."

Concluding the Minister said, "I am committed to the development of these Strategies, which will bring focus to identifying and addressing the issues, barriers and disadvantages that undermine equality of opportunity in our community."

Home Fire Safety Checks

NIFRS is pleased to re-introduce face-to-face Home Fire Safety Checks across Northern Ireland.

What is a Home Fire Safety Check?

A Home Fire Safety Check is a visit to your home to provide advice on how to stay safe from fire. Each visit will be carried out by at least two staff from Northern Ireland Fire & Rescue Service (NIFRS) who will be wearing NIFRS uniform and will carry a NIFRS photographic identification card.

During the visit they will either fit a smoke alarm or show you how to test your existing smoke alarm, explain the potential fire risks in your home, provide fire safety advice and explain the importance of having a night time fire safety routine and a fire escape plan. The visit will take up to 40 minutes. Sometimes it is useful when visiting the property and giving advice, a family member, friend, neighbour or care worker is also present so that they can assist with the advice.

Can I have a Home Fire Safety Check?

You qualify for a Home Fire Safety Check if you someone in your home answers yes to one of the following criteria:

- Is anyone aged 50 or older?
- Does anyone have a disability or impaired mobility (includes people who have an impairment or health condition that would impact on their ability to acknowledge or respond to an emergency in the home)
- Does anyone receive assistance from a visiting agency on a regular basis to help with day-to-day tasks?

How do I apply for a <u>free</u> Home Fire Safety Check? To apply, just ring 028 92 66 4221and request a Home Fire Safety Check or complete a request online at <u>www.nifrs.org</u>



Due to the COVID-19 pandemic, we have changed how we are carrying out Home Fire Safety Checks in order to minimise the risk to the people we visit, and our personnel.

If you require a Home Fire Safety Check and agree to a home visit, you can be assured that our personnel will apply strict COVID-19 measures using appropriate personal protective equipment. What to expect if you agree to a Home Fire Safety Check visit?

NIFRS personnel will telephone on the date of the visit to confirm there are no changes to your circumstances regarding Covid-19

NIFRS personnel will be wearing appropriate Personal Protection Equipment atall times during the visit. This includes –

- Gloves
- Face masks
- Eye protection
- Aprons
- The number of NIFRS personnel entering your home will be limited to two
- NIFRS personnel will stay together while in your home
- We will maintain the maximum social distancing of two metres
- The time we spend in your home will be kept to a minimum
- NIFRS personnel will limit contact with surfaces in your home

If you do not want us to visit your home

Alternatively, if you do not want us to visit your home, we can complete a Home Fire Safety Check over the telephone with you. A follow up visit can be arranged at a later date which suits.

Housing Executive; Let's Connect – Using SignLive

If you are deaf or hard of hearing, you can get contact the Housing Executive using online British (BSL) and Irish Sign Language (ISL) interpretation.

You can discuss your tenancy; access advice and support on your housing situation; report a repair; receive grants assistance and more.

SignLive is a free service that will connect your call to a qualified online BSL or ISL interpreter. The interpreter will relay the conversation between you and a member of Housing Executive staff.

Why use SignLive?

If you're deaf or hard of hearing, the SignLive interpretation service allows you to connect with the Housing Executive and talk securely through a BSL or ISL interpreter.

How it works? British Sign Language Users



You can download the SignLive app on your mobile phone or tablet. Alternatively, you can use SignLive on your computer by visiting <u>www.signlive.co.uk/login</u> The service is available 24 hours a day, 365 days a year.

Irish Sign Language Users

You can use SignLive on your computer by visiting: <u>www.signlive.co.uk/nihe</u>

The service is available Monday to Friday from 9am to 5pm. Calls must be pre-booked a minimum of 4 hours in advance.

Rural Homes NI Blog

Housing Executive Director of Regional Services, Siobhan McCauley, explains how the Rural Housing Need Tests supports rural communities across Northern Ireland.

There is no doubt all of us have been impacted by the lockdown measures due to Covid-19. Suddenly, we were all isolated within our communities and having to rely on our phones to communicate with friends and family, and on TV, radio and social media to keep up-todate with developments and how services were continuing and how they could be accessed.

For many people, especially those who are elderly, vulnerable or just living on their own, the lockdown proved particularly challenging. Doorstep deliveries are just not the same as gong to the shops and having a chat; not being able to see families and loved ones has caused loneliness and distress. Many people may not have embraced mobile technology and will have felt more isolated than ever. When asked to reflect on the particular needs of rural communities, it is not hard for any of us now to relate to the issues which come with living in a remote area. Many people have always been faced with reduced or unavailable services, and, perhaps, dealing with loneliness and social isolation.

At the Housing Executive, we have long recognised that the experience of our urban and rural communities may differ and we must adapt our approach in order to ensure that we fulfil our statutory duty of identifying, assessing and addressing housing need, regardless of location. It is for this reason that we have a dedicated rural unit who are focused on engaging with rural communities and community representatives in order to reach out to anyone who needs and cannot access an affordable housing solution in a rural area. We understand that many people will not approach us when they see there are few housing options available in an area in which they want to reside. Perhaps, this is due to limited availability of social homes in rural areas. Our rural housing need tests are aimed at reaching out to those who need a helping hand to get a decent and affordable home in their rural area. Through engagement – whether it is community meetings, information events, interactions with primary schools, press reports, social media, email or phone calls - we encourage people to come forward to have that important first discussion regarding their housing options. If we find that enough people are added to the waiting list for a given area then we will work with our housing association partners to facilitate a new housing development.

Since 2000, over 200 housing need tests have taken place across NI, enabling almost 400 new social homes to be built for families in areas where housing options where previously limited and people often had to relocate to find the home they required. Housing must come first, before a community can grow and thrive and demand those services and facilities required to support health & well-being and address accessibility issues and social isolation. We, as the strategic housing authority, must ensure that we continue to evolve our rural approach, working together with our partners in local councils and housing associations to respond to the needs of our rural communities and deliver the homes that will help to sustain our rural communities. It all starts with a home.

Building more social homes could add billions to Scotland's post-pandemic economic recovery, says former RBS chief economist

The economic and wellbeing case for building more social homes in Scotland has been laid out in a major new report by Stephen Boyle, former chief economist at the Royal Bank of Scotland. Mr Boyle is calling on the Scottish Government to invest in building more than 35,000 new homes for social rent by 2026, to capitalise on the opportunity to create jobs and boost incomes as well as enhancing health and educational attainment as we emerge from COVID-19. The report, titled 'A new economic case for social housing', is based on economic modelling from the Scottish Policy Foundation and the Fraser of Allander Institute at the University of Strathclyde, and concludes that an investment in social housing could yield billions in return to Scotland's economy, particularly as Scotland continues to get to grips with the global coronavirus pandemic and the socio-economic consequences.

According to the economic analysis in the report:

• Providing houses to people who would have been homeless boosts the supply of labour. That is estimated to add £4.0 billion of gross domestic product (GDP).

 When children live in decent houses their educational attainment and health improve making them more productive in later life. That would add £1.5bn of GDP.



 Building the houses and maintaining them would add up to £6.4bn of GDP and generate an average of 900 jobs per year.

The analysis uses projections for housing need in Scotland for the next parliamentary term. While the report calls for the building of more than 35,000 new social homes, based on updated projections and continued growth in demand for social housing, Shelter Scotland said this figure is now closer to 37,100 homes and is calling on all parties to commit without delay to building the homes that people in Scotland need.

The independent report, which was commissioned by the housing and homelessness charity, makes the economic case for social housing pointing to long-term positive outcomes.

The report claims that this investment would lead to the expansion of the labour force, a boost in national productivity as well as reduced levels of child poverty and increased educational attainment.

Speaking ahead of the launch of the economic analysis report, Stephen Boyle said: "Investment in housing is investment in people in a host of ways, from improving health and education to tackling climate change and reducing poverty. It also delivers much-needed conventional economic benefits of more jobs and higher incomes. While social housing is not the silver bullet that alone will lead Scotland to improved wellbeing and prosperity, the good it promotes and the harms it prevents will go a long way to getting us all there. COVID-19 has underlined the benefits of good quality housing. People who live in sub-standard accommodation or who are homeless are more likely to develop conditions that compromise their immune systems, while overcrowding can make it easier for infections to spread. Children living in unsatisfactory housing arrangements already suffered an educational penalty. School closures are likely to have had an especially adverse effect on them, not least because poor quality, overcrowded and temporary accommodation is not a supportive environment for home schooling. What's more, investing in social housing has the added benefit of boosting jobs and incomes as the economy rebuilds from recession. And we know that a programme of housing investment can be delivered.

"A good quality and affordable home can be the springboard from which children thrive and adults from all walks of life achieve their full potential." Stephen Boyle added: "Investment in social housing can also deliver long-term economic benefits and enhance Scotland's reputation as a place to live, work and bring up a family. Scotland will be a better country in the round if it invests to provide more social housing."

Research by Shelter Scotland, CIH and the Scottish Federation of Housing Associations found that in order to meet the current housing shortfall, Scotland needs to build at least 37,100 social homes between 2021 and 2026.

Campaigners called for an overall investment of £3.4bn to build 53,000 affordable new homes over the period -37,100 of which should be for social rent. During this parliamentary term which will end next May, the Scottish Government has committed to building 50,000 affordable homes - including 35,000 properties for social rent. Earlier this month, the Scottish Government also warned that Scotland's gross domestic product could fall by 14% in 2020 and may not return to pre-pandemic levels until the start of 2023. An estimated 19% of businesses have been temporarily closed, affecting over 750,000 jobs between those furloughed and the self-employed who are unable to work.

Commenting on the launch of Stephen Boyle's report, Alison Watson, director of Shelter Scotland, said: "We welcome the findings of Stephen Boyle's report, which come at a time of great uncertainly for tens of thousands of families and individuals across Scotland who may worry for their jobs, their wellbeing and their homes. However, poverty, homelessness and poor housing are not new, they existed long before the current crisis.

"This analysis, as well as what we're seeing on a daily basis at the sharp end of the housing crisis, shows us that the Scottish Government must do more to deliver the homes people need. While we commend them for building more social homes than ever before, they are in effect running the bath without the plug.

"Scotland needs to build the homes that people need, in places they are needed most. The report shows us that when this happens, we can all benefit through economic and social prosperity. By investing in social homes, we can safeguard the economy and our society against negative impacts such as poverty, trauma and future health crises." There are currently almost 30,000 homeless households in Scotland and 167,000 people of waiting lists for a socially rented home.

The need to help some people in the community to pay bills or carry out shopping on their behalf is likely to continue over the winter months.

The Telecommunity Fund Grant offers grants up to £2000 to support young people, older people and people with disabilities

Who can apply:

Constituted grassroots community and voluntary groups

Criteria:

- Priority will be given to applications from small groups, typically with an annual income of less than £200,000, as evidenced in the most recent set of accounts
- Projects must aim to directly support one of the following specific groups:
 - o Young people
 - o Older people
 - o People with disabilities
- The Fund will not support projects targeting all ages.
- Priority will be given to projects that will benefit groups dealing with disadvantage (e.g. rural isolation, low income, social exclusion, reduced access to services), and projects that involve the beneficiaries in their development and delivery.

Examples of types of projects that may be supported within Fund themes:

- Community education and training opportunities
- Communication and leadership skills
- Local initiatives to improve resources and community facilities
- Creativity and self-expression through drama, music or a range of arts activities
- Inclusion and involvement of disadvantaged communities
- Out of school projects for young people

The Foundation will not fund organisations or activities which promote causes that are contrary to our purposes. Causes and activities that are contrary to our purposes include, but may not be limited to, those outlined in our investment



policy. We will not, therefore, fund organisations or activities which we determine are linked to the promotion of armaments, alcohol, human rights abuses, tobacco or pornography.

The fund will also not support organisations who advance religion, including those who have purposes within their governance to advance religion, or who seek financial support for any projects aimed at advancing a particular religion.

The Telecommunity Fund is open on an ongoing basis. The applications are assessed at panel meetings held approximately 3-4 times per year.

The next panel meeting will take place on 24th November 2020, therefore applications submitted after 27th October 2020 at 12 noon will not be considered in this round.

All ideas must be based around the <u>**'Take 5 Ways of**</u> <u>**Wellbeing'**</u>. These are five simple steps to help maintain and improve your wellbeing on a daily basis.

- Both constituted groups and non-constituted groups can apply for funding.
- There must be a minimum of three people per group

Sport Hardship Fund has reopened

Sport NI in partnership with the Department for Communities are delighted to announce the re-opening of the Sports Hardship Fund; to further help sports clubs and other organisations delivering sporting activities, who are still experiencing financial hardship.

Initially opened on 14 April the Sports Hardship Fund has so far provided support totalling over £1mto help over 500 sports clubs maintain facilities during the lockdown.

This next phase will prioritise new applications for $\pounds 2,000$ and now includes club and organisations who 'block book' (hire) their facilities as well as owning or leasing facilities.

Returning applicants may also apply for a \pounds 1,000 top up to their award if they have fully expended the initial \pounds 2,000.

Who we can support

Eligible organisations delivering sport and physical recreation can apply to our fund if experiencing financial hardship.

These organisations include:

- Governing Bodies of Sport recognised by Sport NI (with and office base in NI)
- Constituted local sports clubs affiliated to a Governing Body of Sport recognised by Sport NI
- Community & Voluntary sector organisations that deliver or enable sport and/or physical recreation as their primary activity. Sports and activities must be recognised by Sport NI.
- Small charitable trusts that deliver or enable sport and/or physical recreation as their primary activity; and do not qualify for financial help elsewhere. Sports and activities must be recognised by Sport NI.

A list of recognised Governing Bodies and activities is available (List of Recognised Governing Bodies & Activities)

What we'll fund

The fund has been developed to help sport and physical recreation organisations meet their obligations, in particular fixed costs, which are no longer supported with revenue as a result of coronavirus.

This might cover expenditure on:

- Facility Hire i.e. block bookings.
- Rent/lease payments
- Heat
- Light
- Utilities
- Water Rates
- Essential grounds/facility maintenance (to maintain a state of readiness
- Some Insurance (essential building/contents insurance, public liability, pro-rata)

How much we'll fund

Each successful applicant (previously not in receipt of a Sports Hardship Fund award) will receive £2,000 towards eligible costs incurred from 1st April 2020. Applicants who have previously received funding from the Sports Hardship Fund may be eligible for an additional grant of £1,000,

Priority will be given to those applicants not previously in receipt of a Sports Hardship Fund award. Organisations **should not apply** if they have:

• Received grant funding through the Department for Economy Retail Hospitality, Tourism and Leisure Grant.
