### Ní Chuilín announces £11.7million support for charities

Communities Minister Carál Ní Chuilín has announced a second phase of the Covid-19 Charities Fund.

The Minister is urging charities to start making application preparations ahead of the opening of the £11.7million fund on 6 January 2021. She explained: "Organisational support will be available between mid-December and the opening date to give applicants time to prepare their applications. This will provide charities with time to collect the necessary information and consider their application with the help of experts. We have more than 8,000 charities that do invaluable work and provide essential support to people when they need it most. This funding will help those charities facing extreme financial pressures as a result of curtailment to their fundraising activities to continue to deliver critical services."

This phase of the Fund will be delivered on behalf of the Executive and the Department for Communities by Community Finance Ireland.

Pre-application information including eligibility, guidance and a Word version of the application form will be available from Monday 14 December on the Community Finance Ireland website. Advice and guidance is available from NICVA and webinars will be held next week. Book your place on a webinar now by going to NICVA's website.

The Fund will provide financial support to charities that have lost income due to the impact of Covid-19 and are unable to cover unavoidable costs between 1 October 2020 and 31 March 2021.

The Minister explained further: "Charities will be able to avail of funding up to £75,000. A diverse range of charities have already received financial support from the first phase announced in June and July 2020.

Previous applicants and awardees will be able to apply in recognition that the support applied to a different six month period; it will also allow charities to apply which were



previously ineligible due to having received other Covid support funding."

Donal Traynor, Group Chief Executive of Community Finance Ireland said: "In our 20-year history, we have helped more than 500 organisations across Northern Ireland, spanning the arts and culture, faith, sports and the social enterprise sectors. We are delighted to continue our support which saw our team's involvement with the recent Covid Social Enterprise Fund on behalf of the Department for Communities and again today by the announcement of the Covid-19 Charities Fund. We have seen first-hand the force for good behind these organisations and the positive change they make to the communities or end users they serve. We are delighted to collaborate in helping to administer this fund at what continues to be a challenging cash-flow period for the charity sector and change-makers in Northern Ireland.

We encourage all applicants to click here Community Finance Ireland where from 14 December they can start to prepare their paperwork and co-ordinate the information required in advance of the January submission deadline."

Commenting on the pre-application support that they can provide, Chief Executive of NICVA Seamus McAleavey said: "NICVA welcomes a further tranche of this much needed funding. NICVA is here to help guide charities in making their applications, starting with a series of webinars next week. Book your place now by going to the NICVA website."

Covid-19 Charities Fund applications can be submitted from 6 January to 22 January 2021.

# Communities Minister's £6.5m additional support for vulnerable people over the Christmas period

Communities Minister Carál Ní Chuilín has allocated a further £6.5million to support those most severely impacted by the Covid-19 pandemic.

The programmes will be delivered in partnership with local councils, health trusts, charities and the community and voluntary sector, to ensure support is directed swiftly to those most in need.

The Minister said: "Throughout this pandemic my priority has been to help those most in need. These additional allocations will allow me to continue to do that as people face the added financial and emotional pressures of Christmas and the New Year.

"This additional funding will help provide access to food, access to support around period poverty and will help to keep people 'warm, well and connected' at a particularly difficult time of the year.

It will be directly targeted at the most vulnerable, including children and young people; carers; older people; people living with a disability; and anyone who has lost income as a result of Covid-19.

"I am acutely aware of the detrimental impact the pandemic has had on people's emotional and physical wellbeing, so addressing loneliness and isolation, emotional wellbeing and financial hardship relating to household bills, is a key focus of this support."



Minister Ní Chuilín continued: "My Department will continue to work with all relevant stakeholders to ensure we get support to those people to address their most basic needs.

"I want to pay tribute to the many organisations and individual volunteers who have been working tirelessly to support our communities and will continue to do so over Christmas and into the New Year."

The Department of Agriculture, Environment and Rural Affairs has also contributed £100,000 to the Warm, Well and Connected programme.

# **Special Focus**

### The 'Perfect Storm': The Impact of COVID-19 on Private Renters in Northern Ireland



A new report on the impact of Covid-19 on private renters in Northern Ireland is launched today. The research uses evidence from case records relating to clients who contacted Housing Rights during the period March-June 2020 and shows that those living in the private rented sector have been disproportionately affected, caught in the 'perfect storm' of low incomes (often as a result of job losses, furlough or reduced hours), job insecurity and tenure insecurity.

#### The economic context

The experiences of private renters are set against the economic context arising from the pandemic and the policy interventions brought about in order to manage the spread of the virus.

The research highlights in particular that:

- Those in lower paid work (including accommodation and food) were more likely to be furloughed – 240,000 workers in NI were on furlough in June 2020 out of a workforce of 790,000.
- There was a 60% reduction in the number of job vacancies in June 2020 compared to the same period in the previous year.
- The claimant count in NI almost doubled in just 3 months between February and May and the rate of new claims from private tenants was more than double that of social tenants.

We know that more lower paid and casual workers live in the private rented sector, including students who rely on their earnings from part time work to pay for their accommodation. All of this suggests that people living in the private rented sector were more likely to be adversely affected by the pandemic.

#### Our clients' experiences

Looking at Housing Rights case records, the report shows that the majority of clients who were calling regarding issues arising as a result of the pandemic and lockdown were living in the private rented sector.

The report looks in detail at a selection of case studies and finds the following:

Almost half of those who had affordability issues were fearful of being evicted as a result of the arrears which they were accruing.

- A high proportion of those affected worked in hospitality or were self-employed.
- Many people were applying for benefits for the first time in their lives and clients reported finding the system difficult to navigate. Particular elements of the system (such as the five week wait for first UC payment) were difficult to cope with.
- Students who contacted Housing Rights were particularly affected by lay-offs and reduced hours (and income) at work, many of whom relied on their income from part-time work to pay for their rent, with little or no alternative support available to them.
- The support provided for many employees and the self-employed was indeed a lifeline, but it is important to remember that it did not reach everyone affected.

#### The way forward

The pandemic and the economic shock which has followed has served to expose fault lines in the housing system. However, there is perhaps the potential to use the experience and knowledge gained to aim to address those issues, which have come into sharp focus as a result of the turmoil caused by the pandemic.

More than anything, this research has shown that the pandemic and subsequent lockdown has affected households in all manner of ways, but that those living in the private rented sector have been disproportionately affected.

In part this may be due to the increasing proportion of low income households in the private rented sector and as such a policy change in favour of social and affordable housing will be key to a post Covid-19 recovery.

The research has also shown that the support that many households received has been immensely helpful, but it has also shown us that it is important to remember that we may all be in the same storm, but we are definitely not in the same boat.

# **Funding**

Finance Minister, Conor Murphy has launched the £20.5 million Dormant Accounts Fund which will provide vital funding to the voluntary, community and social enterprise sectors

The Dormant Accounts Fund will be delivered by The National Lottery Community Fund. Multi-year grants of up to £100,000 will be available to build organisations' resilience and sustainability.

Visiting Footprints social enterprise in West Belfast this morning, Minister Murphy said: "The establishment of the Dormant Accounts Fund is great news for the community, voluntary and social enterprise sectors. While the Fund currently is £20.5 million it will increase as further Dormant Funds are made available each year.

"Third sector groups are often limited to annual funding, causing constant uncertainty and hindering long-term planning. By offering multi-year funding, this Fund will give groups a bridge to become more financially sustainable. Ultimately this allows them to have an even greater impact on people's lives."

Alongside the grant fund, the Dormant Accounts Fund will also support larger, strategic projects that will enable collaboration right across the sector and develop new and creative approaches to sustainability. These could be NI-wide or sector specific proposals which might focus on a particular issue such as diversity and inclusion, social finance or volunteering.



Highlighting what the Dormant Account Fund will support, Kate Beggs, The National Lottery Community Fund's NI Director, added: "The launch of this fund is a milestone for the community and voluntary sector in Northern Ireland. While 2020 has been a year of emergency funding, we know many organisations are trying to plan for the long term and thinking about the changes they need to make to become more sustainable. Those changes require leadership, strategic planning, new skills and strong governance – and also time to stop and think. Those are things for which funding often isn't available and that's where the Dormant Accounts Fund comes in. It will provide flexible, multi-year funding and allow a diverse range of organisations to plan for a more secure future."

The Dormant Accounts Fund will open for applications at noon on Tuesday 12 January.
