### Hargey launches Small Capital Grants Programme

A £950,000 fund to support the voluntary and community sector has been launched by Communities Minister Deirdre Hargey.



The Small Capital Grants Programme, which is delivered by Co-operation Ireland, is aimed at assisting voluntary and community organisations purchase items of equipment to enhance and sustain the activities and services they provide to the community.

Launching the fund, Minister Hargey said: "I am very aware of the difficulties the sector has faced over the last year and now, as we emerge from lockdown and venues begin to re-open, funding from this programme is more important than ever in helping groups to purchase much needed items of equipment that will help to minimise any disruption to the services that people rely so heavily upon. These grants can make a difference and they help to support voluntary and community organisations to provide vital services to local communities. I am pleased that this funding is reaching those most in need." The programme provides grants of between  $\pounds$ 1,500 and  $\pounds$ 5,000 towards the purchase of items such as IT equipment, sporting equipment, catering equipment and material to support arts and cultural activities within the voluntary and community sector.

Applications are invited from constituted organisations that have an annual unrestricted income of no more than £100,000.

Peter Sheridan, Chief Executive of Co-operation Ireland, added: "We are delighted to assist in the delivery of the Small Capital Grants Programme which is in keeping with Co-operation Ireland's ethos of encouraging partnership and collaboration.

We thank the Minister for her commitment to the programme and look forward to building relationships with the hundreds of community groups who will benefit from this much needed programme".

### **Getting Weather Ready – the Regional Community Resilience**

The Regional Community Resilience Group (RCRG) was formed in 2013 to help local communities prepare for and respond to weather related emergencies. During the summer period, we may occasionally experience periods of heavy, thundery rain which could overwhelm drains and culverts, potentially resulting in flash flooding. It is therefore important to remain vigilant and follow some simple precautions that can be taken during this time that may mitigate or even prevent flooding. In addition the current Covid-19 restrictions may also impact on how you and your community respond to a flood event.

- 1. Ensure that contact details in your household and community plan are up to date, particularly for the elderly and vulnerable and new residents etc.
- Stay aware of weather warnings through TV / Radio / Apps. You can register on the Met Office website or download the Met Office app to receive weather warnings on https:// www.metoffice.gov.uk/about-us/what/met-officeweather-app and https://www.metoffice.gov.uk/ weather/warnings-and-advice
- 3. If you notice blocked gullies, or ponding / drainage issues on the road contact Dfl Roads on (https://www.nidirect.gov.uk/services/reportroad- drainage-fault), or; If you notice debris that may have been discarded along river banks which when rivers are swollen could be carried downstream potentially causing a blockage or impede river flows, please report this to your local Dfl Rivers office: https:// www.infrastructure-ni.gov.uk/contacts/

Should you need access to community sandbag containers and have to place sandbags, you should consider the sanitisation of common touch points around containers and the need to maintain social distancing of at least two metres. Further advice and guidance can be accessed on the nidirect website at https:// www.nidirect.gov.uk/campaigns/coronavirus-covid-19.

It is important to emphasise that during a period of severe weather, should the need arise, you should follow the normal procedure and call Flooding Incident Line – 0300 2000 100 to report flooding.

### Minister Hargey to reform gambling laws

Communities Minister Deirdre Hargey has announced plans to deliver the first significant changes to gambling laws here in over 35 years.

Following a public consultation on the issue, the Minister has proposed a two phased approach in order to progress changes in the current Assembly mandate. Minister Hargey said:

"Gambling legislation has remained largely unchanged since it was enacted thirty-five years ago. As a result, gambling regulation here has not kept pace with industry and technological changes. In my view change is long overdue. It is clear from our consultation that people are content for some of the existing legal constraints on gambling to be relaxed. But they also believe that government, the gambling industry and others need to do much more to prevent, control and combat problem gambling. The pragmatic approach I am taking will mean that we deliver some much needed change in the short term, while simultaneously ensuring that complex areas of regulation and online gambling are given the time and consideration they need."

The first phase will be legislation to deliver tangible changes in around 17 key areas mainly around premises based gambling including improving protection for children and young people, as well as some relaxations around hours of operation. The legislation will be introduced in the Assembly in the next few weeks. Amongst other matters it will:

- create new offences in relation to allowing children to play gaming machines;
- create powers to impose a statutory levy on gambling operators;
- establish a mandatory code of practice for those holding gambling licenses;
- broaden the definition of cheating to include attempted cheating;
- make gambling contracts enforceable in law;
- remove some of the restrictions on promotional prize competitions; and
- permit Bookmakers and Bingo clubs to open on Sundays and Good Friday.

Phase two will require a much longer timescale and will include a completely new regulatory framework which will regulate online gambling, including gaming machines.

The Minister also recently announced that she is changing legislation to enable local voluntary groups and clubs to raise vital funds by selling tickets online.

The Department for Communities is developing a new Housing Supply Strategy, as part of the Minister's comprehensive and ambitious programme of work to increase housing supply and address housing stress.

The strategy is intended to provide a long term framework for the development of policy, interventions and action plans to deliver the right homes in the right locations, to help meet current and foreseeable housing needs and demands. As such, it is anticipated that the strategy will make a major contribution to the achievement of strategic outcomes as described in the draft Programme for Government outcomes framework, New Decade New Approach and the Department's strategic plan, 'Building Inclusive Communities'.

This Call for Evidence consultation period will run until 16 July 2021. A further public consultation will take place on the draft Strategy later in the year.

#### **Supporting Communities Reports on Tenant Participation Strategy Progress**

The Tenant Participation Strategy for NI (2015-2020) called for the establishment of an <u>Independent Tenant</u> <u>Organisation</u>. Supporting Communities won the tender for this contract in 2017 and has since taken on responsibility for overseeing the implementation of the Strategy and supporting all social housing tenants and staff to develop the skills needed for effective participation.

As we look forward to a new strategy for 2021 and beyond, we are pleased to report on the progress we have made to date. (The report presentation is on our website.)

We have delivered the main objectives of the first Tenant Participation Strategy, including developing TP Guidance and establishing a Housing Policy Panel made up of tenants from 50% of Northern Ireland's social landlords. We are contributing to the Department for Communities' review of the existing strategy and look forward to strengthening and improving what has already been accomplished.

In his forward to the report, Supporting Communities' Cheif Executive Colm McDaid said, "In our role as ITO, we have expanded our scope to help other social landlords set up structures that work for their businesses and their tenants. Tenant participation is thriving in Northern Ireland, but we cannot and will not rest on these laurels. I have laid out a <u>5 point plan</u> to take tenant participation to the next level, which we look forward to implementing with our partners in the housing sector."

#### **Teachers' exception from fair employment laws**

Blog by Geraldine McGahey, Chief Commissioner, Equality Commission NI Act Now on Teachers' Exception from Fair Employment Laws

It was great to see unity of purpose across the Assembly chamber on Monday 17 May in the debate on removing the exception of teachers from the fair employment laws. It was clear that everyone in the Chamber agreed that teachers deserve the protection of the law at work just as much as everyone else. It is the Commission's view is that all teachers should be able to enjoy the same legislative protections as other workers, and that it is no longer acceptable to exclude the entire teaching workforce from the provisions of the fair employment legislation.

As things stand, it is not unlawful for schools to discriminate on the grounds of religious belief in the appointment and promotion of teachers. It also means that schools are not required to monitor the community composition of teachers, nor consider whether they are providing fair participation in the employment of teachers.

For all these reasons, the Commission has recommended the removal of the exception consistently since publishing research and a subsequent investigation into the issue in 2004. It is our view that the exception should be abolished at secondary level, with early consideration given to whether the exception should also be removed



in primary schools. Since then we have continued to call for action – including for example in our 'Proposals for legislative reform' submitted to the First Minister and Deputy First Minister in 2009; our 2015 recommendations on 'Sharing in education' and our 2016 recommendations for the Programme for Government and Budget, as well as other consultation responses and engagements over the years.

Now it is our sincerest hope that this long-standing equality deficit will be addressed and I urge all our politicians to act for equality in the employment of teachers.

## More than a third of Scots impacted by Scotland's 'broken and biased' housing system

Research for housing and homelessness charity Shelter Scotland shows 1.5 million adults in Scotland (36%) are currently struggling with the condition, security, suitability, or affordability of their home, or been discriminated against while trying to find it. Around 3%, representing more than 130,000 adults, agreed they had experienced discrimination in the search for their current home and felt it was because of their ethnicity, gender, sexual orientation, nationality, religion or disability.

The findings are based on an online poll by *YouGov*. The number of people in unsafe or insecure housing rises to a shocking 1.9 million when children are included in the total.

Shelter Scotland director Alison Watson said: "Scotland's housing system is broken and biased. It is failing people. Hundreds of thousands of people are being held back by the lack of a proper home that would support them to flourish.



You don't have to be living on the streets to be severely impacted by the housing emergency. Hundreds of thousands are putting up with the unacceptable, counting their blessings that it's not worse. We have to stand up and demand better for everyone." The charity said people who agreed they had experienced discrimination when trying to find their current home were almost three times as likely to be struggling with issues such as overcrowding, poor conditions, insecurity or affordability.

#### Case Study - Perry's story

Alison Watson added: "Our housing system is horribly unequal. The fight for home starts here. We're asking people to join us whether they are personally affected by this or not. Together we will campaign to end this injustice."

A Scottish Government spokesman said: "We want everyone to have a home that is warm, safe and affordable and the actions in our long-term housing strategy Housing to 2040 set out how we will achieve that. Creating a home requires more than bricks and mortar, which is why we have committed to realising the right to adequate housing and, as part of that, we will undertake a comprehensive audit of our current housing and homelessness legislation to ensure that it meets the needs of everyone including those who have faced barriers to housing. Scotland has led the way across the UK with almost 100,000 affordable homes delivered since 2007 and we are committed to delivery of a further 100,000 by 2032 – with at least 70% of these available for social rent."



#### Minister launches £1m Rural Halls Refurbishment Scheme

Rural Affairs Minister Edwin Poots MLA has announced the opening of a £1m Rural Halls Refurbishment Scheme.

The pilot scheme will provide capacity building training and a grant to rural community and voluntary organisations to deliver capital refurbishment works to rural halls, with the intended aim of keeping community facilities viable and to support existing rural organisations to remain sustainable and identify new volunteers.

The Rural Halls Refurbishment Scheme will make individual awards of up to a maximum of £40,000 available to rural community organisations.



Funding may be used for a range of small scale refurbishment works and must be located in a rural area.

#### **Ecclesiastical Launches £1m Movement for Good Awards 2021**

For a third successive year, Ecclesiastical Insurance is inviting nominations to its  $\pounds 1$  million Movement for Good Awards.

The programme has two funding phases:

- Phase 1 will award 500 charities with £1,000 each. Nominations will be accepted from 24 May to 13 June 2021. The more nominations a charity receives, the greater their chance of winning. Winners are selected by a draw.

- Jersey Charity Commissioner or the Guernsey Registry (Channel Islands) or the Central Registry (Isle of Man)
- · does not discriminate unlawfully in any way

- does not support any specific political party or affiliated group
- does not relate to any controversial subject matter that is contrary to the values and expectations of the promoter



Eligible charities could range from smaller, volunteerrun groups to larger, well-known organisations.

A charity can win only once but they can be nominated multiple times. The more nominations a charity gets, the more likely they are to win £1,000.

The winners will be selected at random from a pool of nominations and announced on the <u>www.movementforgood.com</u> website from 21 June 2021 to 2 July 2021.

#### Nationwide Building Society Community Grants Opens for 2021 Applications

Nationwide Building Society is offering grants of between £10,000 and £50,000 for projects of either one year or two years. Projects should target one of Nationwide's three outcomes:

- Preventing people from losing their home.
- Helping people in a home.
- Supporting people to thrive within the home . environment.

The funding will support core costs (up to 20% of the grant amount requested); staff and volunteer costs; small-scale capital costs; activity costs; development and capacity building costs ; and building works and refurbishment costs.

Nationwide has made two changes to its 2021 programme:

Charities should have been running for at least three years and have a £25,000 minimum average income over three years.

There is now a cap on the number of applications per region. This has been introduced in order to manage volumes and to preserve a success rate of approximately one in four (25% of those who apply within each region will receive funding). The cap means the date on which applications close in different regions may be earlier than 17 June 2021.

#### Applications will be accepted from 17 May to midnight on 17 June 2021.

#### **UK Community Renewal Fund**

The UK Community Renewal Fund 2021-22 will help support local areas to pilot imaginative new approaches and programmes that unleash their potential, instill pride, and prepare them to take full advantage of the UK Shared Prosperity Fund when it launches in 2022.

There will be a pre-determined national allocation for Northern Ireland, set at £11 million. By treating Northern Ireland as one geographical area they will ensure all communities have equal access to apply for the Fund. Priorities

To nurture innovative thinking and offer flexibility, projects may align with one, or deliver across several, of the following investment priorities:

- Investment in skills
- Investment for local business
- Investment in communities and place
- Supporting people into employment

90% of funding available through the UK Community Renewal Fund is revenue funding, with a small amount of capital funding.

#### How to apply

In Northern Ireland, the UK government will oversee a project competition directly.



Financial due diligence checks will be undertaken on non-public sector applicants. These checks will include an assessment of the applicant's financial standing including the ability to deal with cost overruns, the ability to fund the project and repay funds if required. The outcome of these checks may exclude applicants from further consideration.

Bids should be submitted by applicants to the Ministry of Housing, Communities, and Local Government by noon on Friday 18 June 2021 by emailing UKCommunityRenewalFund@communities.gov.uk. Bids received after the deadline will not be considered. They will then confirm which projects will receive funding from late July onwards.

#### Tampon Tax Fund

 $\pm 11.25$  million to be made available for charities working with disadvantaged women and girls; the threshold for applications reduced to  $\pm 350,000$ 

Charities can now apply for funding to support projects helping thousands of women and girls across the UK, as part of the latest and final round of the Government's Tampon Tax Fund.

A pot of £11.25 million has been made available to charitable organisations to bid for, with priority given to those working to end violence against women and girls, as well as organisations that support a network of charities.

For this round of funding, the grant threshold has been reduced from  $\pounds 1$  million to  $\pounds 350,000$ . This means that more organisations will be able to apply, increasing accessibility to organisations that support this vital work.

The Tampon Tax Fund was introduced in response to VAT being imposed on sanitary products by the European Union, and following this round will have provided more than £90 million of funding supporting women and girls charities.

### **£11.25M** TAMPON TAX FUNDING

As per the government's manifesto commitment, the Chancellor announced at the Budget in March 2020 that the tax would end on 1 January 2021 following the UK's exit from the EU, as per the government's manifesto and wider government strategy to make sanitary products affordable and available for all women.

Grants may be for 12 or 18-month projects, and all activities must be concluded and funds spent by 31 March 2023.
